- ___ \$8 check or money order for the prorated 2017 membership fee. This check will be returned if you are not accepted. Member dues are \$50.00 per year due and payable on Jan. 1st of each year. (call for this amount)
- ___ \$10.00 check or money order for the one time issuance of an Arkansas Craft Guild Stock Certificate. This check will be returned if you are not accepted.

The Guild maintains a website arkansascraftguild.org and information about all members is included without charge. The goal is to have all members represented on the website. All new members Name, Medium and County of residence will be included on the Guild website.

New members are required to submit information for the web as part of the jury process, either by emailing information to Webmaster shawnhoefer@gmail.com and cc: arkcrafguild@mvtel.net, or submit a CD, containing your artist's statement in a text or Word file, and at least 5 photos of your work plus one of you working at your craft -- photos in .jpeg format, at least 1000 x 1000 in size. CDs are not returnable and it is the responsibility of the member to submit this information.
